Treasurer's Report:

\$2712.33 was moved from the money market to the accessibility fund to open a \$10,000 CD. This is a seven-month CD with 5.2% interest. A motion was made to approve the August 2023 Treasurer's report as presented on paper by Kim Davis, 2nd by Trudy Rew, Motion carried.

Old Business:

1) Sunday School Rally Day

Sunday School Rally Day will be at Gilman on 9/24/23.

2) Furnace Service

Dale Place spoke to Issac out of T&S Hardware and if the furnace is running well, no need to do anything. Duey Davis will make sure to change out the filters.

3) Tune Piano and Organ

Both the piano and organ are good. No tuning is needed currently.

4) New CD in Elmwood

\$10,000 was put into a CD in Elmwood for seven months. A six-month option was not available.

5) Fall Festival

Rich Schroeder will be providing music. Kern's could provide egg bakes, fruit, muffins, doughnuts for 50 people at the cost of \$540. Mel Schroeder will donate her time and the cost of the food for 50 people will need to be covered. She will provide French toast, sausage, bacon, scrambled eggs or egg bake, juice, and milk. Mel still needs to provide an estimate of the cost of food. Jessica Hanson will be promoting this Fall Festival on social media. The council agrees that whoever comes in with the lowest price for the food is who will provide the breakfast for fall

festival. Randy Nyeggen will decorate the church for the fall festive.

On 9/13/23: a quote was received from Mel Schroeder and the cost for the food will be \$160. This will be for 12 dozen eggs, 6 loaves of French bread, Sausage Gravy, Biscuits, Fresh Fruit, Muffins. The council approved Mel Schroeder to provide the meal at the fall festival via email.

6) Still looking for Parish Administrator

No one has been found and still looking.

7) Call Committee Members

Aaron Hanson has agreed to be a call committee member. Still need to find more volunteers.

8) 2023 LP Contract

The 2023 LP at \$1.499 has been signed and sent it.

9) Septic, Sidewalks, Black Dirt and Tree

The sidewalk needs a sealer put on before winter. Septic and tree removal still need to be looked at. Still need black dirt by church. Duey will contact Jason Anderson about this.

10) Sunday School Teachers

Spring Lake does have Sunday School Teachers. Missy and Donna will continue.
