New Business:

- **A. Approval of the Budget:** The 2023 proposed budget was reviewed. For 2022, St. John's portion of the Parish budget was 50%; for 2023, it will be 40%. It was noted that the 2022 budget was higher than the expenditures. The Pastoral portion of the Parish expenses was explained and discussed. Motion by Kathy Miller, seconded by Paula Hampton, to approve the 2023 budget as proposed. Motion carried.
- **B.** Delegates to Synod Assembly: Laura Hennemann agreed to be one of two attendees.
- **C. Nominating Committee:** It is preferred to have two outgoing Council members and two other congregation members. Lisa Nelson, Rob Moore, Mel Wentlandt, and Marsha Brunkhorst agreed to be on the nominating committee for the 2024 Council.
- **D. Sunday School Building:** The Food Pantry currently pays St. John's \$125 per quarter towards expenses. The actual utility expenses are \$200-\$300 per month. There was discussion on the building's condition, needed updates, and insurance.

Election Results: There were 29 voting members signed in, with 29 ballots turned in. All votes were unanimous.

Closing: There was a motion by Marsha Brunkhorst, second by Rob Moore, to adjourn. Motion carried and the meeting was adjourned at 10:51 a.m. We closed with the Lord's Prayer
